I, Hector Concepcion, created that Facebook page and owns the domain name www.nytriskelion.com, which I obtained at the same time. I have both since I was the first Info Comm officer and served until March 2023. I told the new set of officers that I was stepping down because I wanted a break and to focus on helping Global.

I also want to point out that this page has been attached to my account since I created it. It's also that same page on which the complainants are in violation of the NYT bylaws: Annex A and Annex B. The same page was also used to ruin one brother's life because of their personal grudge against the brother.

They demand that I remove myself, but if they are the owners, how come they cannot remove me or request that I remove myself from the Page's settings? Annex C

Their complaint wouldn't exist if the current NYT officers granted my demands on my complaint filed in August 2023 that they step down from office due to the gross violation of the TCoC and the NYT bylaws. Their violations will be turning a year old this June 16 and have not been heard yet. It's preposterous that their complaint be heard first before our complaint.


ARTICLE I NAME

THE MISSION AND VISION OF THE NYT






